1. Consider approving the minutes of the November 15, 2023 Board of Supervisors Meeting:

Vice-Chairman Haas moved to approve the minutes of the November 15, 2023 Board of Supervisors Meeting. Supervisor Lucas seconded the motion. All voted in favor; none opposed.

TREASURER'S REPORT: A copy of the bill list is on the table

Vice-Chairman Haas moved to approve checks #14872-14915 from the General Fund, checks #2091-2098 from the Recreation Fund, check #1203 from the Donation Fund, and checks #0079-0088 from the Escrow Fund. Supervisor Lucas seconded the motion. All voted in favor; none opposed.

NEW BUSINESS:

1. Consider approval of Act 101 Recycling Ordinance/ set Hearing date

Chairman Lehman moved to set the hearing date for the Act 101 Recycling Ordinance for 6:30 pm on January 17, 2024. Supervisor Novak seconded the motion. All voted in favor; none opposed.

2. Discuss Operating Reserve Fund Certificate of Deposit purchase(s), authorizing renewal via Resolution

Vice-Chairman Haas moved to pass Resolution #667-2023, a Resolution of the Board of Supervisors of the Township of Pequea, Lancaster County, Pennsylvania, authorizing the purchase of a certificate of deposit. The Board of Supervisors of the Township hereby authorizes the Treasurer to transfer unencumbered Operating Reserve Fund monies in the amount of approximately \$162,843.00 to a Certificate of Deposit for a period of 1 year. Chairman Lehman seconded the motion. All voted in favor; none opposed.

Vice-Chairman Haas then moved to pass Resolution #668-2023, a Resolution of the Board of Supervisors of the Township of Pequea, Lancaster County, Pennsylvania, authorizing the purchase of a certificate of deposit. The Board of Supervisors of the Township hereby authorizes the Treasurer to transfer unencumbered Operating Reserve Fund monies in the approximate amount of \$162,827.00 to a Certificate of Deposit for a period of 1 year. Chairman Lehman seconded the motion. All voted in favor; none opposed.

3. Discuss Transfer of 2023 unencumbered funds to the Capital Reserve Fund via Resolution

Vice-Chairman Haas moved to pass Resolution #669-2023, a Resolution of the Board of Supervisors of the Township of Pequea, Lancaster County, Pennsylvania, authorizing the Transfer of Unencumbered Monies from the General Fund to the Capital Reserve Fund. Whereas the Board wishes to transfer \$225,000.00 to the Capital Reserve Fund for roads, bridges and culverts. Supervisor Lucas seconded the motion. All voted in favor; none opposed.

Vice-Chairman Haas then moved to pass Resolution #670-2023, a Resolution of the Board of Supervisors of the Township of Pequea, Lancaster County, Pennsylvania, authorizing the Transfer of Unencumbered Monies from the General Fund to the Capital Reserve Fund. Whereas the Board wishes to transfer \$225,000.00 to the Capital Reserve Fund for equipment. Supervisor Novak seconded the motion. All voted in favor; none opposed.

4. Consider Pioneer Management, LLC request #1 for reduction of LINKBANK Standby Letter of Credit #6200099752 for work completed on West Penn Grant Self-Storage (DMR Willow LLC)

Supervisor Lucas moved that we reduce the letter of credit by \$822,029.90 and establish a new amount equal to \$20,800.00 for West Penn Grant Self-Storage, a letter of Credit Reduction-Request #1, As-Built Plan Review #1. Vice-Chairman Haas seconded the motion. All voted in favor; none opposed.

Pequea Township Road Department- Road Department. Supervisor Haas reported tree trimming, crack sealing, and gutter filling as recent projects.
