Supervisor Lucas moved to approve the minutes of the March 19, 2025 Board of Supervisors Meeting. Supervisor Novak seconded the motion. All voted in favor; none opposed.

Vice-Chairman Haas moved to approve the Treasurer's Report: checks #15623-15660 from the General

PUBLIC COMMENTS: (following Chairman Lehman's synopsis of the 13 agenda items) **Items on the agenda:**

Frank Cazillo noted the lack of communication between the election bureau and our fire companies regarding compensation to the fire companies for hosting election polling places. He thanked the Township for compensating the fire companies for the financial shortfall in the two elections to be held in 2025.

1. Consider Approval of the Land Development and Storm Water Management Plans for WAWA-3102 Willow Street Pike

2. Award the Bid of the Silver Mine Park Stream Restoration Project

Chairman Lehman moved to award the Bank Restoration Project to CH&N Site Construction in the amount of \$39,961.35. Supervisor Novak seconded the motion. All voted in favor; none opposed.

3. Award the Bid of the Hike & Bike Trail for Silver Mine Park

Vice-Chairman Haas moved to award the bid of the Hike and Bike Trail for Silver Mine Park to Kinsley Construction in the amount of \$93,181.25. Chairman Lehman seconded the motion. All voted in favor; none opposed.

4. Appoint Roadmaster

Vice-Chairman Haas moved to appoint Dylan Rineer as roadmaster effective March 31, 2025. Supervisor Novak seconded the motion. All voted in favor; none opposed.

5. Consider Approval of a Memorial Tree at Silver Mine Park in Memory of Ronald Fryberger

Supervisor Lucas moved to approve placement of a memorial tree at Silver Mine Park in memory of Ronald Fryberger. Vice-Chairman Haas seconded the motion. All voted in favor; none opposed.

6. Consider Approving the Date of Tuesday, August 5, 2025 for National Night Out

Supervisor Kreider moved to set the date of August 5, 2025 for National Night Out. Supervisor Lucas seconded the motion. All voted in favor; none opposed.

7. Consider Approval to Execute the PennDOT Traffic Signal Maintenance Agreement (TSMA)

Chairman Lehman moved to execute the PennDOT traffic signal maintenance agreement. Supervisor Lucas seconded the motion. All voted in favor; none opposed.

8. Consider Approval of the PennDOT Traffic Signal Maintenance Agreement via Resolution

Chairman Lehman moved to pass **Resolution #730-2025**, a **Resolution to approve the PennDOT Traffic Signal Maintenance Agreement**. Supervisor Lucas seconded the motion. All voted in favor; none opposed.

9. Consider Request for Financial Security Release #1; Cody Harnish, 189 Marticville Road

Supervisor Lucas moved that we reduce the financial security from\$10,169.00 to \$4,631.00 for Cody Harnish at 189 Marticville Road. Vice-Chairman Haas seconded the motion. All voted in favor; none opposed.

10. Consider Approval of a Well Isolation Waiver for 14 Clairmont Drive

11. Consider Transfer of Capital Reserve Funds to Purchase Upfitting of 2024 Dump Truck via Resolution

Vice-Chairman Haas moved to pass **Resolution #731-2025**, whereas The Board wishes to transfer approximately \$100,000 from the Capital Reserve Future Expense Fund to the General Fund for upfitting purchase of dump truck. Chairman Lehman seconded the motion. All voted in favor; none opposed.

12. Consider Approval for Mike Hall to Attend the 2025 Township Emergency Management Spring Seminar on May 4. 2025.

Supervisor Novak moved that we share one half of the fee for attendance and gas mileage for Mike Hall to attend this event. The other half of the expenses will be paid by Martic Township.
