\*Appeals Under Local Agency Law - Every request for a hearing under the Local Agency Law, 2 Pa. C.S. §551 et seq., for which the Township has not established a specific fee by other resolution or ordinance shall be accompanied by a fee in the amount of \$500.00. A stenographic record of the proceedings shall be kept. The appearance fee for a stenographer shall be borne or reimbursed to the Township entirely by the person or entity requiring a hearing. The cost of the original transcript shall be paid by the Township if the transcript is ordered by the Township or shall be paid by the person or entity requesting such copy or copies. In all other cases, the party requesting the original transcript shall bear the cost thereof

**Building Permit Fees:**

- Fees determined by Pequea Township appointed third party building inspection agencies
- Zoning Permit Fee plus 15% of third-party inspection agency fee
- \$4.50 State mandated surcharge for all Building Permit Applications

**Additional Permit Fees:**

If the excavation for, the construction or erection of any building, including accessory buildings or the alteration of any building, including accessory buildings or the alteration of any building or any use

change or structure that requires a permit begins before a permit is issued, the zoning permit fee is double the original fee plus one hundred (\$100.00) dollars.

Incomplete and/or applications returned to the applicant for additional information shall be subject to a fee of \$90.00 per hour for review and processing of the permit.

- Major Land Disturbance \$500.00 per application
- Major Land Disturbance \$2,000.00 deposit per application\*
- Waiver/Modification of the provisions of the Ordinance (Major Land Disturbance) \$50.00 per request

- Minor Land Disturbance \$1200.00 Permit Review and Inspection Fee\*

\*If, in the opinion of the Township Designee, the deposits filed by any applicant have been reduced to a point that in good faith it is not deemed probable that the reviews can be accomplished by Township Officials within the budget of said deposits, the Township Designee shall require a submission of additional deposits, from time to time, so to adequately secure the payment of all Township costs and expenses, in review of and associated with, all subdivision and land development plans.

### **Property Maintenance Code Fees for Inspections, Violations, and Legal Actions:**

The following fee schedule shall be applicable to be charged against the Owner(s) and/or Tenant(s) of the premises who are found to be in violation of the provisions of the Property Maintenance Code by the Pequea Township Code Enforcement Officer.

Initial Inspection, Violation Notice and Report (One Inspector)	No Charge
Second and Subsequent Inspections and Reports/Notices (One Inspector)	\$100.00 per hour
Legal Expenses of Township and Court Costs for Non-Compliance	\$250.00 per hour
All administrative expenses, mileage charges, and materials including but not limited to test kits and barrier tape	Actual Cost

Payment of all the above fees shall be due to the Township within thirty (30) days of the date of the delivery of the invoice to the responsible party or parties, and if not paid within the thirty (30) days, the party or parties shall pay to the Township interest from the due date to the date

paid at the legal rate allowable under the law. The party or parties who are subject to the violation notice could be subject to additional charges for fines, penalties, attorney fees and other costs if legal action is required before the District Magistrate or the Court of Common Pleas of Lancaster County to correct the violation.

1. No fee for modification requests submitted with the original submission package.
2. The administrative fee is non-refundable.
3. The deposit account is for engineering and solicitor costs outlined by Section 801 of this Ordinance. The applicant will be sent monthly invoices for costs accrued. The escrow shall be refunded to the applicant upon project completion and payment of all outstanding invoices, if applicable.
4. Fees for improvement construction plans shall be the same as those for preliminary or final plans.
5. Fees subject to change by resolution of the Pequea Township Board of Supervisors.

### **SMALL WIRELESS COMMUNICATION FACILITIES APPLICATION**

Pursuant to Ordinance 218-2023, the Board of Supervisors determined a fee of Three Hundred Dollars (\$300.00) will be collected to regulate implementation of small wireless communication facilities within the Township, in accordance with requirements set forth in Act 50 of 2021, the Small Wireless Facilities Deployment Act.

### **FEE IN LIEU OF PARKLAND**

Pursuant to Resolution 305-2006, the Board of Supervisors determined a fee of One Thousand Five Hundred Dollars (\$1,500.00) per individual residential lot or individual dwelling unit shall be the fee in lieu of dedication of park and recreational land in Pequea Township.

**Right to Know Fees:**

Paper copies 8 1/2" X 11" & 8 1/2" X 14" \* shall be 25 cents per page per side, for B&W copies. Color copies shall be 50 cents per page per side. The certification of a record is \$5 per record. Specialized documents including, but not limited to, blue prints, color copies, and non - standard sized documents shall be charged the actual cost of production. If mailing is requested, the cost of postage will be charged. If the transfer of files to a USB drive is requested, the cost of an 8GB USB drive will be charged. The township reserves the right to require prepayment for documents if the estimated charges for said documents are \$100.00 or more.



**Returned Check Fees:**

Pequea Township will charge a fee of \$50.00 (fifty dollars) to cover bank charges, administrative fees, and any other fees and charges incurred by the municipality for any check that is returned to the Township due to insufficient funds, an account being closed, or for any other reason. The Township has the right to refuse payment by check from anyone who has previously had a check that was returned to the Township.
